The list of stores continues in a similar manner to the above examples and to list them all is unnecessary.

This concludes the receipt book of the Appletreewick Mining Co. but all the receipts have not been reproduced, as that would have made the work too long and boring for the reader. Although in part I am afraid I have left the reader high and dry with the exact facts as shown, this is entirely due to my own lack of knowledge of the workings of this mine. I hope that any member reading this series of articles, who can pick up the story or add to it from the facts related, will do so in future issues of this publication.
